

GUIDE TO 2023 NOMINATION FORM 100 Most Influential Filipina Women in the World Award (Global FWN100™)

Thank you for your interest in submitting your nomination for the Most Influential Filipina Women in the World Award.

The deadline for online submission of nominations is JUNE 30, 2023.

To help you gather and organize the information and documents about your nominee, this Guide outlines the questions that appear on the 2023 Global FWN100™ Awards Nomination Form.

Nominations may only be submitted online at www.filipinasummit.org/nominate. The deadline for the submission of nominations is JUNE 30, 2023.

Before you begin — NOMINATORS and potential NOMINEES — please review the following guidelines before submitting a Global FWN100™ nomination:

- 1. Please use a desktop to complete the nomination form for the best results and a smoother experience. Using your phone, tablet, or iPad will not work and will create tech problems for you.
- 2. Online Nominations only submitted at www.filipinasummit.org/nominate
- 3. FWN requires the nominee's permission for nomination for one of the award categories.
- 4. As the nominator, you must explain the award requirements to your nominee.
- 5. Answer all the questions to complete the nomination. Do not leave any questions unanswered.
- 6. A process that has worked for others: prepare your nomination on a Word document, then cut/paste on the online form's questions.
- 7. Prepare in advance all the documents needed to upload to the nomination form. Incomplete forms will be returned.
- 8. Allocate at least 60 minutes to complete the nomination.
- 9. IMPORTANT— To exit the form and return later to complete it, you must click the "Save and Continue" button at the bottom of the page. You will receive an email with a link. To access your previously saved nomination, use the link sent to you in the email on the same browser and computer or device.
- 10. The nominator signs off on the integrity of the nominee's info to accept your nomination.

- 11. IMPORTANT— FWN may use the nomination information you submit in announcements and materials to publicize the nominee and the Global FWN100™ Gala Awards and Ceremony at the annual Filipina Leadership Global Summit.
- 12. IMPORTANT— FWN publishes all approved nominations on the Global FWN100[™] Nomination web page for at least 60 days to allow the public to vet your nominee.

Global FWN100™ Awardee requirements

Being selected for the Most Influential Filipina Woman in the World Award (Global FWN100™) is the ultimate recognition given by FWN. This is a Working Award. It comes with accountability and responsibility. Selected Nominees sign the Global FWN100™ Award Terms of Agreement when notified of award selection.

Awardees are included in the FWN Honor Roll and may use the award designation including the FWN and Global FWN100™ logos on their letterhead, business card, website, and in their career portfolio and bios as long as they are awardees in good standing with FWN and the business community. Here are the requirements to receive the award designation:

- 1. Commit to maintaining FWN Awardee status in good standing.
- 2. Commit to an annual Awardee Contribution of \$250 renewed yearly.
- 3. Attend the Filipina Global Leadership Summit the year nominee is selected to complete the awarding process and annually after selection.
- 4. Commit to nominating at least one outstanding, influential colleague annually in her profession, industry, workplace, or community in her geographic area.
- 5. Sign up as a Femtor and be part of developing FWN's talent pipeline of next-generation leaders. To sign up as a femtor, go to www.femtormatch.org/femtor-application. More info about FemtorMatch, go to www.femtormatch.org. Awardee can also sign up as a Femtee to enhance her skill sets in areas where she needs improvement. Sign up as Femtee at www.femtormatch.org/femtee-application.
- 6. Commit to submitting ONE innovative and NEW project to benefit the Filipina women community in the nominee's geographic area and complete the project within two years of the nominee's award selection.

- o The proposed project will receive extra points if the nominee's project has collaborators, investors, supporters, or partners, ideally from fellow Global FWN100™ Awardees of previous years.
- When selected, the awardee will present her winning proposed project at the Filipina Leadership Global Summit the year she receives her award.
- The following immediate year, the awardee will present her completed project at the next Filipina Leadership Global Summit.
- The proposed project presentation is an opportunity to engage and invite previous awardees to collaborate with her project.
- Awardees of previous years will be encouraged to collaborate with or support the awardee's proposed project at the Filipina Summit.

DISCLOSURE

FWN reserves the right to withdraw the Global FWN100™ Award designation if the awardee has been deemed no longer in good standing with FWN and the global business and Filipino community. FWN sends a Cease-and-Desist Letter to the awardee who is no longer in good standing to cease using the FWN logo, the Most Influential Filipina Woman in the World Award designation and logo, in their bios, resumes, websites, blogs, marketing collaterals, and social media.

 workplace environment, displaying a deep passion for a cause through collaborative

 her own company. Builders demonstrate high potential and skill with measurable results at
 government agencies, higher education institutions, non-profits, or corporations in the public
 and private sectors. "Buildership" is about developing better organizations, leading broken
 organizations to adjust, repair, and re-align, including journalistic views redefining traditional
 methods.
 - EMERGING LEADER (below age 35): This award category recognizes Filipina women below age 35 who are making their mark in a leadership role and are on the pathway to principalship and building capacity across an organizational system. Emerging Leaders have powerful mindsets and skill sets that help drive performance for their organizations. Emerging Leaders may be renominated after three years to another award category when they are over 35 and continues to be influential.

- FOUNDER & PIONEER: This award honors Filipina women as the chief executive, president, executive director, or founder of a company, community organization, non-profit, or business venture they helped start, build, or significantly grow. This award category is for the trailblazers who have marshaled resources and applied innovative practices, processes, or technologies in a new and groundbreaking way to address a significant business or organizational opportunity.
- INNOVATOR & THOUGHT LEADER: This award recognizes Filipina women who have broken new ground in the global workplace and delivered unique applications of emerging technology. This award is for women who have influenced how people think in business, education, sports, literature, journalism, the arts, and pop culture, improving the lives of others by developing a product or service in the fields of finance, science, engineering, fashion, publishing, cuisine, architecture, film, and entertainment. This award category is also for someone who has launched a new enterprise, a learning function, or completely overhauled an existing way of doing things, resulting in a new development or community initiative.
- NICOLE: This award honors a Filipina woman whose words, actions, and activism inspire
 others to act and revolutionize society's understanding of traditional beliefs and customs, thus
 leaving behind a Filipino global imprint. "Nicole" is named after the young woman identified as
 "Nicole," who sparked an international dialogue about women's rights, national sovereignty,
 and international law as she steadfastly pursued justice against her four rapists, inspiring this
 category.
- POLICYMAKER & VISIONARY: This award recognizes Filipina women leaders who have
 demonstrated exceptional business acumen combined with a forward-looking vision in the
 development or influencing of policies, campaigns, or laws that impact business, industry,
 and society; leaders who enrich the lives, careers, and businesses of others by sharing the
 benefits of their wealth, experience, and knowledge; actions that significantly change how we
 think and live.
- KEEPER OF THE FLAME: Sustaining Global Pinay Power is quite daunting. As the
 excitement dies down and the reality of executing FWN's Vision sets in, many drop out, and
 others pick up the torch. The Keepers of the Flame are US FWN100™ and Global
 FWN100™ awardees who are the caretakers that ensure the FWN Vision is kept alive.

FWN VISION: Be the resource for professional and personal development for women of Philippine ancestry worldwide.

FWN MISSION: A Filipina woman leader in every sector of the global economy.

Indicate who was involved in creating the plan and their specific role. This question weighs heavily in your nominee's award selection. (20 points) *

- PROJECT IMPLEMENTATION of the award selection criteria you marked: Describe the steps taken. In general terms, how did the activities flow? Were there any difficulties encountered? IMPORTANT: When selected, the awardee will present her winning proposed project at the Global Pitch Forum, a highlight of the 2023 Filipina Leadership Global Summit in Prague, Czechia, on 29OCT-02NOV, where the nominee will receive her award.
